

1. DEFINITIONS AND INTERPRETATION

In these Conditions:

1.1 the following terms have the following meanings:

"Affiliate" any persons that Control, are Controlled by or are under common Control with us from time to time;

"Change" any mechanical, software or other change in design, manufacturing process, supply chain, specifications, materials or product standards (including part substitutions or internal relocation of parts) which affects or potentially affects performance, reliability, function, safety, appearance, quality, dimensions, tolerances or any other Specifications of Deliverables.

"Claims" claims or proceedings made, brought or threatened against us by any person;

"Confidential Information" any Contract and any information that relates to a party (or any of its Affiliates) disclosed to the other party in connection with the Contract, but excluding information received by the other party that: (i) is publicly available (other than through a breach of Condition 0); (ii) was received from a third party who did not acquire it in confidence; or (iii) is developed without any breach of the Contract;

"Contract" a contract for the supply of Deliverables by you to us incorporating these Conditions, including pursuant to a Framework Agreement, as formed under Condition 2.1 (Contract Formation);

"Control" in relation to a person, the power to direct or cause the direction of its affairs, whether by means of holding shares, possessing voting power, exercising contractual powers or otherwise and "Controlled" is construed accordingly;

"Customer ESG Policies" our and our Affiliates' policies and statements which are available at www.smiths.com from time to time and which apply to entities which supply any good or services to us or any of our Affiliates including our and our Affiliate's procurement policies, sustainability policies, HSE policies and water waste and biodegradability statements, in each case as amended from time to time.

"Cyber Security Incident" means (a) any information security incident or any event or incident having an adverse effect on any element of the security of the IT infrastructure of us or any of our Affiliates, you or any of your permitted subcontractors; (b) any reasonably suspected event or "near miss" incident; (c) any event or incident involving any breach of security leading to a loss of any data of, controlled by or in the possession of us or our Affiliates or controlled by, processed or in the possession of you and/or your permitted subcontractors in connection or as a result of this Contract; (d) any event or incident which involves the compromise of confidentiality, integrity and or availability of data.

"Deliverables" means Goods, Work Product and/or Services;

"Delivery" delivery of the Goods in accordance with Condition 4 (Delivery of Goods / Supply of Services);

"ESG" environmental, social and governance factors and standards;

"Framework Agreement" a framework agreement in place between you and us for the supply of Deliverables incorporating these Conditions;

"Force Majeure Event" means any unforeseen and unforeseeable event arising which is beyond the reasonable control of the affected party (including any industrial dispute affecting any third party, fire, flood, disaster, civil riot or war, but excluding pandemic, public health events, industrial disputes, labour disturbances or strikes facing the Supplier or its subcontractors, breakdown or failure of equipment and any failures of supplier's to the Supplier or its subcontractors).

"Goods" the goods set out in the Order or any Specification or referred to in the Framework Agreement;

"IPR" all intellectual and industrial property rights of any kind including patents, trade secrets, supplementary protection certificates, rights in know-how, registered and unregistered trade marks and designs, models, rights to prevent passing off or unfair competition and copyright, database rights, topography rights, any rights in any invention, discovery or process, and applications for and rights to apply for any of the foregoing, in all countries in the world and together with all renewals, extensions, continuations, divisions, reissues, re-examinations and substitutions;

"IPR Claim" a Claim that the possession, use and/or sale of Deliverables by us, our Affiliate or our or their customers infringes the IPR of any person;

"Liability" liability arising out of or in connection with a Contract, whether in contract, tort, misrepresentation, restitution, under statute or otherwise including any liability under an indemnity contained in a Contract and/or arising from a breach of, failure to perform, or delay in performing any of a party's obligations under a Contract, howsoever caused including if by negligence;

"Losses" all losses, liabilities, costs, demands, damages and expenses that are or will be incurred by us or our Affiliates including in respect of any Claims, including IPR Claims;

"Order" our written acceptance of your quotation for the supply of Deliverables to us AND/OR any purchase order submitted by us to you for Deliverables;

"Price" (i) the lower of the price for the Deliverables set out in the Order and your price for the Deliverables in force at the time of Delivery of Goods or completion of Services; or (ii) where there is a Framework Agreement in place, the price for the Deliverables as set out in the Framework Agreement;

"Services" the services set out in the Order or any Specification or referred to in the Framework Agreement;

"Specification" the specifications and requirements for the Deliverables set out or referred to in the Order or as defined in the Framework Agreement;

"Supplier Personnel" has the meaning given to it in Condition 17.6

1. 定義和解釋

在本條件中：

1.1. 下列術語應具有下列含義：

"**關聯人**" 指不時控制我方、受我方控制或與我方共同受控制的任何人員；

"**改變**" 指在設計、製造過程、供應鏈、規格、材料或產品標準方面影響或可能影響可交付成果的性能、可靠性、功能、安全性、外觀、品質、尺寸、公差或任何其他規格的任何機械、軟體或其他改變（包括部件替換或部件內部遷移）。

"**索賠**" 指任何人針對我方提出、提起或揚言提起的索賠或程式；

"**保密資訊**" 指任何合同和針對該合同向另一方披露的與該方（或其任何關聯人）有關的任何資訊，但不包括另一方收到的下列資訊：（i）可公開獲得的（除違反第 12 條外）；（ii）從並非基於保密而獲得該資訊的協力廠商處獲得的；或（iii）在不違反合同的情況下開發的；

"**合同**" 指根據第 2.1 條（合同的訂立）所訂立納入本條件的貴方向我方供應可交付成果的合同，包括框架協議；

"**控制**"，就某人而言，指指示或促致指示其事務的權力，無論通過持有股份、擁有表決權、行使合同權力或其他方式，且"**受控**"應做相應解釋；

"**客戶 ESG 政策**" 指我方及我方關聯人時不時於 www.smiths.com 網站上公佈、適用於所有向我們或任何關聯人供應商品或服務之實體的政策與聲明，當中涵蓋我方及我方關聯人的採購政策、可持續發展政策、健康安全環境（HSE）政策，以及水資源廢棄物與生物降解性聲明，各項內容均以不時修訂的版本為準。

"**網絡安全事故**" 指 (a) 任何對我方或任何關聯人、貴方或貴方任何獲准分包商之資訊科技基建安全構成不利影響的資訊安全事故或任何事件；(b) 任何合理懷疑的事件或「險些發生」的事故；(c) 任何涉及安全漏洞、導致與本合同相關或因其而造成的資料損失之事件或事故，該等資料為我方或我方關聯人所擁有、控制或持有，或由貴方及/或貴方獲准分包商控制、處理或持有；(d) 任何涉及損害資料保密性、完整性及/或可用性的事件或事故。

"**可交付成果**" 指貨物、工作產品和/或服務；

"**交付**" 指根據第 4 條（交付貨物/提供服務）；

"**ESG**" 指環境、社會及管治因素與標準；

"**框架協議**" 指貴方和我方之間為提供可交付成果而訂立的包含本條件的框架協議；

"**不可抗力事件**" 指受影響一方無法合理控制、且既未預見亦不可預見的任何事件（涵蓋影響任何第三方的工業糾紛、火災、水災、災難、內亂或戰爭；但不包括供應商或其分包商所面對的疫症、公共衛生事件、工業糾紛、勞工騷亂或罷工、設備故障，以及供應商或其分包商自身的供應商出現的任何失靈情況）。

"**貨物**" 指訂單或任何規格中規定的或框架協議提及的貨物；

"**智慧財產權**" 指任何種類的所有智慧財產權和工業產權，包括專利、商業秘密、補充保護證書、專有知識、註冊和未註冊的商標和外觀設計、模型、防止假冒或不正當競爭的權利和著作權、資料庫權、拓撲權，任何發明、發現或方法中的任何權利，以及在世界所有國家申請和有權申請前述任何權利，連同所有續期、展期、延期、分立、重新簽發、重新審查和替換；

"**智慧財產權索賠**" 指認為我方、我方關聯人或我方或其客戶持有、使用和/或銷售可交付成果侵犯任何人智慧財產權的主張；

"**責任**" 由合同引起的或與合同有關的責任，無論基於合同、侵權、虛假陳述、償還、制定法或其他方面，包括合同中賠償條款項下的任何責任和/或由違反、未履行或延遲履行合同項下任何一方的義務，不論如何產生，包括由於疏忽造成的；

"**損失**" 指我方或我方關聯人發生或將會發生的包括針對任何索賠（包括智慧財產權索賠）在內的所有損失、債務、成本、要求、損害賠償和支出；

"**訂單**" 指我方書面接受貴方向我方提供可交付成果的報價和/或我方向貴方提交的針對可交付成果的任何採購訂單；

"**價格**"（i）訂單中規定可交付成果的價格和交付貨物或完成服務時貴方針對可交付成果屆時有效的價格，以較低者為準；或（ii）已有框架協定的情況下，框架協定中規定的可交付成果的價格；

"**服務**" 指訂單或任何規格中規定的或框架協定中提及的服務；

"**規格**" 指訂單中規定或提及的或框架協議中定義的可交付成果的規格和要求；

"**供應商人員**" 一詞的定義載於第 17.6 條。

"we" or "us" or "our" the person named as the customer in the Order and/or referred to as "Customer" in a Framework Agreement;

"Work Product" any reports, documents, work product or other materials created for us by you, or on your behalf, arising from the Services;

"you" the person named as the supplier in the Order and/or referred to as the "Supplier" in a Framework Agreement;

1.2 headings are for ease of reference and do not affect the interpretation of these Conditions;

1.3 references to a "person" include any individual, body corporate, partnership, government authority, agency or department, state or any other entity (in each case whether or not having separate legal personality);

1.4 any words following the words "include", "in particular" or any similar expressions will be construed without limitation and accordingly will not limit the meaning of the words preceding them;

1.5 an obligation on a party to procure or make sure the performance or standing of another person will be construed as a primary obligation of that party; and

1.6 a reference to a statute or statutory provision is a reference to it as amended or re-enacted. A reference to a statute or statutory provision includes all subordinate legislation made under that statute or statutory provision.

1.7 the English language version of these Conditions is the binding version as between you and us. Any translation has been prepared for convenience only. In the event of any conflict, ambiguity or inconsistency between the English language version of these Conditions and any translated version, the English language version shall prevail.

2. CONTRACT FORMATION

2.1 A Contract is formed when we accept any quotation issued by you (verbal or written) by issuing an Order (whether or not there is a Framework Agreement in place) OR where you perform any act consistent with fulfilling an Order submitted by us for Deliverables. We are not obliged to accept any quotation issued by you.

2.2 These Conditions are the only terms and conditions on which we will purchase Deliverables. They apply in place of any terms and conditions that you may seek to apply or which may otherwise be implied, including any which are endorsed on, delivered with or contained in your quotation, Order acknowledgement, on your website or other sales materials or media or on any delivery note ("Seller T&Cs") and you waive any rights to rely on any such Seller T&Cs. Delivery of Goods and/or commencement of performance of Services is conclusive evidence of your acceptance of these Conditions.

2.3 You may not cancel a Contract. Unless you notified us in writing before we placed an Order that we may not cancel it, we may cancel a Contract in whole or part any time before Delivery or completion of performance of Services. Our sole Liability will be to pay to you fair and reasonable compensation for work-in-progress at the time of cancellation provided that:

2.3.1 such compensation will not include any loss of profits OR any indirect or consequential loss; and

2.3.2 where Goods are not manufactured specifically for us to our Specification, our sole Liability will be to pay you a fair and reasonable restocking charge.

3. QUALITY CONTROL & TESTING

3.1 The quantity, description and Specification of Deliverables will be as set out in the Order. You must not make any Change to Deliverables without our prior written consent. You will carry out any reasonable Change that we request to any Deliverables. We will negotiate, in good faith, with you an agreed adjustment to the price, Delivery date or both as a result of a Change.

3.2 You will maintain detailed quality control and manufacturing records for the shorter of any maximum period permitted by law and at least ten (10) years from the date of Delivery (or such other period of time as set out in a Framework Agreement or Order) from the date of Delivery of Goods which we or a third party on our behalf may inspect or receive copies of on demand.

3.3 We may inspect and test Goods at any time prior to Delivery. You will allow us and our representatives to enter your premises to carry out such inspection and testing and will provide us with all facilities reasonably required. If, following such inspection or testing, we are not satisfied that the Goods will comply with **Condition 5.1 (Your Obligations)**, you will take all steps necessary to ensure compliance at no additional cost to us.

3.4 You will maintain a quality control system that meets any international standard as required by us, or which is otherwise approved by us and such test and inspection system as we may require.

3.5 You may not deliver the Goods by separate instalments without our prior written consent. Instalments will be invoiced separately by you.

4. DELIVERY OF GOODS / SUPPLY OF SERVICES

4.1 Unless otherwise specified in an Order, you will deliver the Goods DDP (Incoterms 2020) to the address specified in the Order during our normal business hours on the date specified in the Order. You will be responsible for off-loading the Goods from the delivery vehicle. Delivery of the Goods will occur when they have been offloaded at the delivery address.

4.2 You will perform Services in accordance with the applicable timetable communicated to you or as set out in the Order to meet all Specifications.

4.3 Time is of the essence for performance of your obligations under the Contract. If you are late performing your obligations under the Contract, you will pay to us liquidated damages of 1.5% of the Price for each week of delay up to a maximum of 15% of the Price. You and we agree that this amount is reasonable and proportionate AND the most effective way of compensating us for part or all of our

"工作產品"指由貴方或代表貴方為我方製作的產生於服務的任何報告、檔、工作產品或其他材料；

"貴方"指訂單中被指定為供應商和/或在框架協議中被稱為供應商的人；

1.2. 標題僅供參考之便，不影響對本條件的解釋；

1.3. 對"人"的提述包括任何個人、法人團體、合夥、政府當局、機構或部門、州或任何其他實體（在每種情況下無論是否具有獨立法人資格）；

1.4. 前接"包括"、"具體地"或任何類似表述的任何詞語將被解釋為沒有限制，並且相應地不會限制在其之前詞語的含義；

1.5. 一方促成或確保另一方履行或資格的義務將被解釋為該方的主要義務；

1.6. 對制定法或制定法規定的提述是對經修訂或重新頒佈的制定法或制定法規定的提述。對制定法或制定法規定的提述包括根據該制定法或制定法規定制定的所有次級立法

1.7. 本條件的英文版本是貴方和我方之間具有約束力的版本。任何翻譯僅為方便而備。如果本條件的英文版本與任何翻譯版本之間有任何衝突、不明確或不一致之處，應以英文版本為準。

2. 合同的訂立

2.1. 我方通過簽發訂單（無論是否存在框架協議）接受貴方（口頭或書面）簽發的任何報價，或貴方實施與履行我方針對可交付成果提交的訂單相一致的任何行為時，合同成立。我方沒有義務接受貴方簽發的任何報價。

2.2. 本條件是我方據以購買可交付成果的唯一條款和條件。其替代適用貴方尋求適用或貴方網站或其他銷售材料或媒體或任何交付單上顯示的任何條款和條件（"賣方條款和條件"），包括貴方報價、訂單確認書中背書、交付或所含任何條款和條件，且貴方放棄信賴任何該賣方條款和條件的權利。交付貨物和/或開始履行服務是貴方接受本條件的確認性證據。

2.3. 貴方不得取消合同。除非貴方在我方下訂單前書面告知我方不得取消合同，否則我方可在交付或完成履行服務前任何時間全部或部分取消合同。我方的唯一責任是在取消時針對正在進行的工作向您支付公平合理的補償，但：

2.3.1. 該補償不包括任何利潤損失或任何間接或結果產生的損失；且

2.3.2. 如果貨物不是按照我方規格專為我方生產，我方的唯一責任是向您支付公平合理的補償費用。

3. 品質核對總和測試

3.1. 可交付成果的數量、描述和規格將在訂單中列出。未經我方事先書面同意，貴方不得對"可交付成果"作出任何更改。貴方將執行我方針對任何可交付成果提出的任何合理更改。我方將誠意與您就因更改而產生的價格、交貨日期或兩者的調整達成一致。

3.2. 貴方將保存詳細的品質核對總和生產記錄，保存時間為法律允許的最長時間和自交貨之日起至少十（10）年（或框架協定或訂單中規定的其他時間期間），以較短者為準；自交貨日起計，我方或代表我方的第三方可以查看或應要求獲得文本複本。

3.3. 我方可在交貨前任何時間核對總和測試貨物。貴方將允許我方和我方代表進入貴方營業場所進行該核對總和測試，並將向我方提供合理要求的所有設施。如果在該檢驗或測試後，我們認為貨物不符合第 5.1 條（貴方義務）規定，貴方將採取一切必要措施確保其符合規定，而我方無須承擔額外成本。

3.4. 貴方將維持符合我方要求的任何國際標準的品質檢驗體系，或者由我方以其他方式同意的品質檢驗體系，以及我方可能要求的核對總和測試。

3.5. 未經我方事先書面同意，貴方不得分期分批交付貨物。分期分批貨物將由貴方單獨開具發票。

4. 交付貨物/提供服務

4.1. 除非訂單中另行明確規定，貴方應在訂單中指定日期正常營業時間期間將貨物按照完稅後交貨（DDP, Incoterms 2020）交付至訂單中指定的位址。貴方將負責從運輸工具上卸載貨物。貨物在交付地址卸貨後，視為交付貨物。

4.2. 貴方將根據傳達給貴方或訂單中規定的相關時間表履行服務，以符合所有規格。

4.3. 時間對履行貴方在合同項下的義務至關重要。如果貴方延遲履行貴方在合同項下的義務，貴方每延遲一周將向我方支付價格 1.5% 的算定損害賠償金額，但最高為價格的 15%。貴方和我方同意該金額是合理和相稱的，並且是賠償我方部分或全部因延遲履行而遭受損失的最有效方式。然而，貴方和我方意欲，如果我方因貴方延遲履行

- losses arising from late performance. However, you and we intend that we should be able to recover general damages as well as liquidated damages in circumstances where we have suffered loss in excess of the liquidated damages as a result of your late performance. Therefore, our rights to any liquidated damages under this **Conditions 4.3** is without prejudice to any other rights which we may have under the Contract or otherwise in respect of late performance, including the right to sue for damages or other relief and/or to terminate the Contract. A claim for general damages for late performance will be reduced by the amount of liquidated damages pursuant to **Conditions 4.3** actually applied or paid in respect of such late performance.
- 4.4** Services will be accepted by us when we are satisfied that the Services comply with the Specifications.
- 4.5** You will make sure that the Goods are marked in accordance with our instructions and any applicable laws, rules and regulations and are properly packed and secured; marked with information on their origin; Delivery is accompanied by a prominently displayed delivery note showing the Order number, date of Order, type and quantity of Goods, and any special storage instructions; and delivered with all operating and safety instructions, clearly displayed warning notices and such other information as may be necessary for the proper use, maintenance and repair of the Goods.
- 4.6** If you fail to deliver the Goods on time we may terminate the Contract immediately by giving you notice, in which case you will refund any monies already paid by us in relation to the Goods that have not been delivered and indemnify us and our Affiliates against our Losses as a result of your failure to supply Goods, including obtaining substitute goods from another supplier.
- 4.7** We will have a reasonable period of time following Delivery to inspect Goods. We may reject Goods which do not meet Specifications. We can also reject Goods which are more or less than the quantity or type Ordered or delivered prior to the date specified on the Order. Rejected Goods will be returned at your cost and expense. If we accept Goods delivered prior to the date specified on the Order we may charge you the cost of storing them until the actual specified Delivery date.
- 4.8** Risk in the Goods passes to us on the later of acceptance and Delivery. Ownership of the Goods passes to us on the earlier of payment of the Price and Delivery.
- 4.9** You will notify us in writing as soon you are aware that any Goods or the product support for the Goods are to be discontinued or made of "end of sale" or "end of life". At our request, you and we will agree in good faith a reasonable period of time during which you will keep agreed spare parts available for us for any discontinued, desupported, end of life or end of sale Goods. You shall provide us a last time buy opportunity at a price not exceeding the then current pricing for such existing Deliverable or (at our choice) a right of first refusal to purchase all or a portion of your remaining inventory for a price not exceeding the then current pricing.
- 5. YOUR OBLIGATIONS**
- 5.1** You will make sure that the Goods will:
- 5.1.1 be of satisfactory quality, comprise genuine, new materials (which are not used, refurbished, reconditioned, remanufactured, counterfeit or of such age as to impair usefulness or safety) and be fit for any purpose notified by us to you;
- 5.1.2 conform to, satisfy and be capable of the Specifications;
- 5.1.3 be free from defects in design, materials and workmanship;
- 5.1.4 be sold to us with full and unencumbered title and not infringe the IPR of any third party;
- 5.1.5 comply with all (i) applicable laws, (ii) regulatory requirements and (iii) standards (or local equivalent) and requirements of relevant statutory and regulatory bodies; and
- 5.1.6 be safe and without risk to health.
- 5.2** In respect of Services, You will:
- 5.2.1 perform Services with the best care, skill and diligence in accordance with best practice;
- 5.2.2 use personnel (and sufficient number of personnel) who are suitably skilled and experienced to perform the Services;
- 5.2.3 make sure that the Services conform with our reasonable instructions, comply with Specifications, are performed to meet the purposes notified by us to you and do not infringe the IPR of any third party;
- 5.2.4 provide all equipment, tools and vehicles and other items required to provide the Services;
- 5.2.5 obtain and at all times maintain all licences and consents required for the provision of the Services;
- 5.2.6 comply with all applicable laws, regulations, regulatory policies, guidelines or industry codes which may apply to the provision of the Services; and
- 5.2.7 not do or omit to do anything which may cause us or our Affiliates to lose any licence, authority, consent or permission required for our or their business.
- 5.3** You will observe all health and safety rules and regulations and any other security requirements that apply at any of our premises and ensure that your personnel are insured against all risks while working on our premises.
- 5.4** Without affecting any of our other rights or remedies, if you materially breach any of these Conditions OR any Goods (whether or not accepted in whole or in part) do not conform with **Condition 5.1** during the longer of (i) your warranty period for the Goods and (ii) 12 months following Delivery OR any Services breach **Condition 5.2**, then we may:
- 5.4.1 terminate the Contract and any other existing Contracts immediately with
- 而遭受的損失超過算定損害賠償，我方應該能夠獲得一般損害賠償和算定損害賠償。因此，我方根據本**第 4.3 條**獲得任何該等金額的權利不會影響我方針對延遲履行根據合同或其他而享有的任何其他權利，包括起訴獲得損害賠償或其他救濟和/或終止合同。因延遲履行而主張獲得的一般損害賠償，將扣除根據**第 4.3 條**針對該延遲履行實際適用或支付的金額。
- 4.4.** 我方信納服務符合規格時，視為我方接受服務。
- 4.5.** 貴方應確保貨物根據我方指示和任何相關法律、法規和規章進行標示，且妥善包裝和保管；標示有關其原產地的資訊；交貨應附有突出顯示的交貨單，表明訂單編號、訂單日期、貨物類型和數量，以及任何特殊存儲說明；交貨應附有所有操作和安全說明、清晰顯示的警告，以及正確使用、維護和修理貨物所需的其他資訊。
- 4.6.** 如果貴方未能按時交付貨物，我方可通知貴方立即終止合同，在該情況下，貴方將退還我方針對未交付貨物已支付的任何款項，並賠償我方和我方關聯人因貴方未提供貨物而遭受的損失，包括從其他供應商處獲得替代貨物。
- 4.7.** 交貨後我方可在合理期間內檢查貨物。我方可拒絕不符合規格的貨物。我們亦可拒絕大於或小於訂購品質或類型的貨物，或在訂單規定日期前交付的貨物。拒絕貨物的返還將由貴方承擔費用和支出。如果我方接受訂單指定日期前交付的貨物，我方可向貴方收取實際規定交付日期前產生的存放費用。
- 4.8.** 貨物風險在驗收和交付（以較遲發生者為準）後轉移至我方。貨物的所有權在付款和交付（以較早發生者為準）時轉移至我方。
- 4.9.** 如果貴方獲悉將中斷任何貨物或產品支援或“停止銷售”或“停止生產”，貴方應儘快以書面方式告知我方。應我方要求，貴方和我方將善意約定一段合理期間，在此期間貴方將針對任何中斷、不提供支援、停止銷售或停止生產的貨物向我方提供約定的備件。貴方須給予我方最後採購機會，價格不超過該交付成果的當時價格；或（由我方選擇）授予我方優先購買權，以不高於當時價格購買貴方全部或部分剩餘庫存。
- 5. 貴方義務**
- 5.1.** 貴方將確保貨物：
- 5.1.1. 品質令人滿意，含有全新材料（不是已使用、翻新、修復、再製造、假冒或具備損害使用性或安全性的陳舊程度），且適合我們告知貴方的任何用途；
- 5.1.2. 符合、滿足且具備規格；

- 5.6 If, as a result of any Goods not conforming with **Condition 5.1** or Services not conforming with **Condition 5.2** or otherwise representing an unreasonable risk of harm to the public or the environment, we determine a recall, removal or correction campaign ("campaign") is necessary or are required to carry out a campaign, we may implement such campaign and you will indemnify us and our Affiliates against all Losses incurred as a result of any such campaign.
- 5.7 You will, upon our request, promptly provide accurate and complete documentation in a form acceptable to us as may be required to permit Smiths to comply fully with all applicable governmental regulations or requirements that enable us to claim relief or tariff and/or duty exemptions, reductions or preferential treatment. This includes but is not limited to:
- 5.7.1 Valid certificates of origin in compliance with the requirements of any applicable free trade agreements, or where there is no applicable free trade agreement, standard certificate(s) of origin in the form which we may reasonably request;
- 5.7.2 Harmonised Tariff Schedule codes for the Goods;
- 5.7.3 Manufacturer's affidavits confirming the origin of the Goods;
- 5.7.4 Documentation of smelt or mill origin (such as smelter or mill certificates) to verify the country(ies) of origin of materials or inputs, including first country of smelt / mill and country of cast / pour; and
- 5.7.5 Any additional records or declarations required by applicable customs authorities to validate costs and places of origin of the Goods and materials contained therein or used in the performance thereof and support claims for relief from any tariff or duty.
- 5.8 You will retain all documentation in connection with Condition 5.7 for a period of no less than 5 years. You will notify us immediately in writing of any changes to information previously supplied which affects the origin, composition or eligibility of goods for preferential tariff treatment. If you do not comply with Condition 5.7 or this Condition 5.8, this will be a material breach of these Conditions.
- 6. OUR PROPERTY**
- 6.1 All patterns, dies, moulds or other tooling or materials, supplied by us or prepared or obtained by you for us at our cost ("**Tooling**"), will be marked with our name or as otherwise specified by us and will be and remain our exclusive property returnable in good condition on demand.
- 6.2 You will insure against all risks any Tooling and also any of your own tooling or property which may be kept on our premises for the purposes of providing Deliverables. You will keep all Tooling safe and in good condition while in your custody and/or under your control. All Tooling will be kept separately from your stock and other inventory.
- 6.3 We reserve the right to charge to you the cost of any Tooling if it is destroyed or damaged or rendered unfit for the purpose for which it was originally manufactured while under your control.
- 6.4 You will not dispose of any Tooling other than in accordance with our prior written instructions. You will not, at any time, use Tooling, nor will you allow Tooling to be used by anyone else for any purpose other than the supply of the Deliverables unless we have previously provided our consent in writing.
- 6.5 We will have the right to enter your premises and remove Tooling at any time without being liable for trespass or for damages of any sort.
- 7. IPR**
- 7.1 This **Condition 7** will apply if the Goods are to be made, modified or redesigned to our Specification. Any bespoke Specification or Work Product you create or have created for us will be treated as "Goods" for the purposes of this **Condition 7 (IPR)**.
- 7.2 We will own all present and future IPR (together with all economic and other proprietary rights) in the Goods and our specification. Accordingly, you will not use our specification other than to manufacture the Goods for us. With full title guarantee, you:
- 7.2.1 assign to us all IPR in the Goods which subsist as at the date of the Contract;
- 7.2.2 assign to us (by way of present assignment of the future copyright) all future copyright in the Goods immediately upon their creation; and
- 7.2.3 agree to assign to us all other IPR in the Goods immediately upon their creation.
- 7.3 You will:
- 7.3.1 at your own cost, execute all such documents and do all such acts and things as we may request from time to time in order to secure our full right, title and interest in the IPR in the Goods; and
- 7.3.2 obtain the waiver of all moral rights (and any broadly equivalent rights) in the Goods.

- 8. PRICE AND PAYMENT**
- 8.1 As long as you perform your obligations in accordance with the terms of the Contract, we will pay the Price to you in accordance with this **Condition 8 (Price and Payment)**.
- 8.2 The only sums of money we will pay in connection with the supply of the Deliverables are the Price which will be inclusive of all costs and expenses incurred by you including all packaging, insurance, carriage, duties and delivery costs.
- 8.3 Any sum payable under the Contract is exclusive of value added tax, sales tax and/or goods and services tax (and any other similar or equivalent taxes, duties, fees and levies imposed from time to time by any government or other authority) upon any supply made to us which will be payable in addition to that sum in the manner and at the rate prescribed by law from time to time but inclusive of all other taxes, fees and levies imposed from time to time by any government or other authority. Any import duties or tariffs shall not be separately chargeable to us pursuant to Delivery Condition 4.1.
- 8.4 You may invoice us for the Price for the Goods following Delivery and for Services following completion.

- 8.7 We may withhold payment of any disputed sum until the dispute is settled.
- 8.8 If any undisputed sum payable under the Contract is not paid when due you may charge us interest daily on that sum at 2% per year subject to any maximum or minimum rate of interest on overdue invoices specified by applicable law from the due date until the date of payment (whether before or after judgment).
- 8.9 We may set-off, deduct or withhold any liability which you have to us against any liability which we have to you.
- 9. TERMINATION**
- 9.1 Without limiting any other right we may have to terminate a Contract, if you commit a material breach of these Conditions we may terminate the Contract and any other existing Contracts immediately with written notice. Any breach of **Conditions 12 (Confidentiality), 14 (Ethical Conduct) or 17.9 (Assignments)** will be deemed to be a material breach.
- 9.2 Without limiting any other right we may have to terminate a Contract, we may terminate the Contract immediately by giving you written notice if you (a) have a receiver, administrator or liquidator (provisional or otherwise) appointed; (b) are subject to a notice of intention to appoint an administrator or any other resolution on insolvency; (c) pass a resolution for your winding-up; (d) have a winding-up order made by a court in respect of you; (e) enter into any composition or arrangement with creditors; (f) cease to carry on business; (g) are the subject of anything similar or equivalent to that set out in (a) to (f) under any applicable laws; or (h) you are subject to any change of Control and you will notify us immediately upon the occurrence of any such event or circumstance.
- 9.3 Following expiry or termination of the Contract:

- 9.4 If we terminate a Contract, we may require you to deliver to us any supplies, materials or drawings produced or acquired by you for the terminated part of the Contract and we will agree, in good faith, on the amount payable for the same.

- 10.1 You will indemnify us and our Affiliates against all our and their Losses arising from your breach of or negligent performance of or your failure to perform or delay in performing any part of these Conditions. - 13.1** A party who becomes aware of a Force Majeure Event which gives rise to, or which is likely to give rise to, any failure or delay in performing its obligations under this Agreement will forthwith notify the other in writing and will inform the other in such notification of the period for which it is estimated that such failure or delay will continue. The affected party will:
- 13.1.1 take all reasonable steps to mitigate the effect of the Force Majeure Event;
- 13.1.2 keep the other party regularly informed in writing of all developments relating to the Force Majeure Event; and

- 10.5.** 本**第 10 條（責任和保險）**規定的責任排除和限制將分別予以考慮。任何條款無效或不可強制履行均不會影響任何其他條款的有效性或可強制履行性，且將被視為可相互分割。
- 10.6.** 貴方應向有信譽的保險人購買令人滿意的保險，承保貴方針對我方的義務，包括公共責任險、潛在合同責任險和法律規定的保險。應我方要求，貴方應提供保險證據。
- 11. 網絡安全事故**
- 11.1.** 若發生任何可能影響貨物或服務供應能力的網絡安全事故，貴方須及時通知我方，並就為恢復正常運作所採取之步驟提供最新進展。貴方同意與我方合作，評估事故對我方供應鏈的影響，並回應任何與事故相關的合理資料索取要求。
- 12. 保密性**
- 12.1.** 除第 12.2 條規定外，各方將：
- 12.1.1. 僅為了履行其在合同項下的權利和義務而使用另一方的保密資訊；
- 12.1.2. 使對方的保密資訊處於保密、安全、有保障的狀態；且
- 12.1.3. 不向任何其他人披露對方的保密資訊。
- 12.2.** 在下列情況下，各方可披露對方的保密資訊：
- 12.2.1. 在法律、任何有管轄權的法院或任何政府、公共或監管機構或任何證券交易所的規章所要求的範圍內；和
- 12.2.2. 向需要保密資訊以履行其在合同項下權利和義務的其高級職員、董事、僱員和專業顧問，以及就我方而言，我方關聯人、代理人和分包商。一方根據**第 12.2.2 條**披露另一方保密資訊時，應確保獲披露保密資訊的每個人受保密義務約束的程度，不低於本**第 12 條（保密性）**規定的程度。
- 12.3.** 各方承認並同意，損害賠償本身並不足以成為該方違反**第 12 條（保密性）**行為的充分救濟。因此，另一方將有權在無需證明特別損害賠償的情況下，針對前者違反或可能違反**第 12 條（保密性）**規定的行為獲得禁令救濟、衡平救濟和/或強制履行。
- 13. 不可抗力**
- 13.1.** 任何一方若知悉發生不可抗力事件，並已造成或可能造成其未能或延遲履行本協議義務，須立即以書面通知另一方，並於通知中說明預計此等履約受阻或延遲將持續多久。受影響一方將：
- 13.1.1. 採取一切合理步驟，以減輕不可抗力事件所造成的影響；
- 13.1.2. 定期以書面向另一方通報有關該不可抗力事件的所有最新情況；和
- 13.1.3. 繼續按協議條款履行所有未受該不可抗力事件影響的義務。
- 13.2.** 若供應商因不可抗力事件而未能提供或延遲提供任何服務或交付成果，客戶無須為此付款，亦無須就此向供應商支付任何費用。對於客戶已預付、但因不可抗力事件而未能交付或提供的任何服務或交付成果，供應商須立即向客戶退還相關款項。
- 13.3.** 倘若供應商持續受不可抗力事件影響超過三十 (30) 天，客戶可隨時以書面通知供應商，即時終止本協議（及/或任何或所有工作說明書）。
- 14. 道德行為**
- 14.1.** 貴方應遵守我方的 “ 供應商商業道德準則 ”

Supplier Code of Business Ethics (<http://www.smiths.com/responsibility-supplier-code-of-business-ethics.aspx>) or an equivalent code of ethics.

- 14.2 You represent and warrant that you and your subcontractors and suppliers do not use or permit unacceptable labour practices, such as child or forced labour, or unsafe working conditions and comply with all applicable labour and employment laws, regulations, standards and conventions, including the, the UN's Guiding Principles on Business & Human Rights and the International Labor Organization's Conventions and any similar or equivalent laws applying in the jurisdiction in which we are registered.
- 14.3 You hereby acknowledge that you are aware of, and agree to comply with all applicable anti-bribery and anti-corruption laws, including but not limited to the Foreign Corrupt Practices Act (FCPA) (and related regulation and guidance) and any similar or equivalent laws applying in the jurisdiction in which we are registered.
- 14.4 You represent and warrant that you only supply minerals to us and our Affiliates from sources that do not (i) contribute to conflict; and/or (ii) benefit or finance armed groups in the Democratic Republic of Congo or any adjoining country. You have adopted, and require your suppliers of minerals to adopt, conflict mineral policies and management systems.
- 14.5 You will permit us, and any person nominated by us, to have such access to your premises, personnel, systems, books and records as we may require to verify your compliance with this **Condition 14 (Ethical Conduct)**. We also reserve the right to inquire and investigate your conduct to satisfy our self of your compliance with this **Condition 14 (Ethical Conduct)** and to discontinue a business relationship with you if you or any of your officers, directors or employees is found to have breached any part of this **Condition 14 (Ethical Conduct)**.
- 14.6 We are required to demonstrate that our products and our use of certain materials comply with laws and regulations (including environmental laws and regulations) and international standards. You will promptly provide us with information and declarations that we may reasonably request to enable us to comply with all applicable laws, regulations and standards, including but not limited to IEC 62474 - Material Declaration for Product of and for the Electrotechnical Industry.
- 14.7 In performing your obligations under the Contract, you will and will procure that your sub-contractors will use reasonable endeavors to comply with the Customer ESG Policies and will comply with all laws and regulations relating to ESG.

15. NOTICES

- 15.1 Notices and other communications provided for the purposes of a Contract will be in writing, and delivered by courier or by hand to the relevant party's address as specified on the Order (or such other address which is notified to the other party in writing from time to time), in the case of a notice to us, marked for the attention of such person as we specify.

16. EXPORT / IMPORT / ECONOMIC SANCTIONS CONTROLS

- 16.1 You agree to comply with all applicable export controls and import and economic sanctions laws and regulations, including those of your country of incorporation, from where the Goods will be supplied, where the Goods will be received and any other relevant jurisdiction. You will also obtain, as required, and comply with all applicable government authorizations and their provisos in supplying the Goods. Without limiting the foregoing, you will not transfer any export controlled item, data or services provided by us in relation to the Contract, to include transfer to any persons, including those persons employed by or associated with, or under contract to you or your lower-tier suppliers, without the authority of an applicable licence, exemption or exception.
- 16.2 You are responsible for exporting the Goods and for importing the Goods into the country in which we are registered, including the payment of any tariffs or duties on the imported merchandise.
- 16.3 You will provide to us all information necessary to support any regulatory or government authorization requirements we have regarding the Goods.
- 16.4 You will indemnify us and our Affiliates for all Losses arising out of any breach by you of this **Condition 16 (Export / Import / Economic Sanctions Controls)**.

17. GENERAL

- 17.1 The Contract constitutes the entire agreement between the parties and supersedes any prior agreement or arrangement in respect of its subject matter and:
- 17.1.1 neither party has entered into the Contract in reliance upon, and it will have no remedy in respect of, any misrepresentation, representation or statement (whether made by the other party or any other person and whether made by the first party or any other person) which is not expressly set out in the Contract; and
- 17.1.2 nothing in **Condition 17.1** will limit or exclude the liability of any person for fraud or fraudulent misrepresentation.
- 17.2 A party's delay in exercising, partial exercising or failure to exercise a right or remedy under the Contract will not constitute a waiver of, or prevent or restrict future exercise of, that or any other right or remedy. A waiver of any right, remedy, breach or default will only be valid if it is in writing and signed by the party giving it.
- 17.3 If any term of the Contract is found by any court or body or authority of competent jurisdiction to be illegal, unlawful, void or unenforceable, such term will be deemed to be severed from the Contract and this will not affect the remainder of the Contract which will continue in full force and effect.
- 17.4 Except to the extent otherwise specified in these Conditions, variations to the Contract must be agreed in writing and signed by both parties.

- 14.2. 貴方陳述和保證，貴方和貴方的分包商和供應商不會使用或允許不可接受的勞動行為，如童工或強迫勞動或不安全的工作條件，遵守所有相關勞動和職業法律、法規、標準和慣例，包括聯合國的《工商企業與人權問題指導原則》和國際勞工組織的各項公約，以及適用於我方登記所在司法管轄區的任何類似或同等法律。
- 14.3. 貴方特此確認，貴方瞭解並同意遵守所有相關的反賄賂和反腐敗法律，包括但不限於《海外反腐敗法》(FCPA) (及相關法規和指南) 以及適用於我方登記所在司法管轄區的任何類似或同等法律。
- 14.4. 貴方陳述和保證，貴方向我方和我方關聯人供應礦產的來源不得 (i) 導致衝突；和/或 (ii) 使剛果民主共和國或任何相鄰國家的武裝團體獲得利益或資助。貴方已採納並要求貴方礦產供應商採納衝突礦產政策和管理體系。
- 14.5. 貴方將允許我方及我方任命的任何人獲取我方要求的許可權，查看貴方的經營場所、人員、系統、帳簿和記錄，以驗證貴方是否遵守本第 14 條 (道德行為)。我方亦保留對貴方行為進行查詢和調查的權利，以信納貴方遵守本第 14 條 (道德行為) 規定，且如果貴方或貴方任何高級職員、董事或員工被認定違反本第 14 條 (道德行為) 任何部分，我方有權終止與貴方的業務關係。
- 14.6. 我們需要證明我們的產品和使用的材料符合法律法規 (包括環境相關的法律法規) 和國際標準。您將及時向我們提供我們合理要求的資訊和聲明，以使我們能夠遵守所有適用的法律、法規和標準，這標準包括但不限於 IEC 62474 - 電工行業產品聲明。
- 14.7. 在履行本合同義務時，貴方須 (並應確保貴方的分包商) 盡合理努力遵從客戶的 ESG 政策，且須遵守所有與 ESG 相關的法律法規。
15. 通知
- 15.1. 為合同目的提供的通知和其他通訊應採用書面形式，通過快遞或親自交付至訂單指定的相關方位址 (或不時書面告知另一方的其他地址)，如向我方發出通知，請註明收件人為我方指定人員。
16. 出口/進口/經濟制裁控制
- 16.1. 貴方同意遵守所有相關出口管制及進口和經濟制裁的法律法規，包括貴方公司成立地、貨物供應地、收貨地和任何其他相關司法管轄區的法律法規。貴方還應獲得並遵守所有相關政府授權和其針對供應貨物的附帶條件。在不限制前述規定的情況下，如果不存在任何相關許可、豁免或例外情況，貴方不得轉讓我方針對合同提供的任何出口管制物品、資料或服務，包括向任何人轉讓，包括受僱於貴方或貴方下級供應商或與貴方或貴方下級供應商有關聯或有合同關係。
- 16.2. 貴方負責將貨物出口以及將貨物進口至我們註冊所在的家，包括支付進口商品的任何關稅或稅項。
- 16.3. 貴方將向我方提供所有必要資訊，以支援我方滿足針對貨物的任何監管或政府授權要求。
- 16.4. 因貴方違反本第 16 條 (出口/進口/經濟制裁控制) 而產生的任何損失，貴方將向我方和我方關聯人進行賠償。
17. 一般規定
- 17.1. 合同構成雙方之間針對其標的的完整協議，取代任何先前協議或安排，且：
- 17.1.1 任何一方訂立合同均未信賴合同未明確規定的任何虛假陳述、陳述或聲明 (無論由另一方或任何其他人作出或由該方或任何其他人作出)，且不會對此享有任何救濟；和
- 17.1.2 第 17.1 條的任何條款，均不會限制或免除任何人就欺詐或欺詐性失實陳述所須承擔的責任。
- 17.2. 一方延遲履行、部分履行或未履行合同項下的權利或救濟不構成對該權利或任何其他權利或救濟的放棄，阻止或限制今後對該權利或任何其他權利或救濟的行使。對任何權利、救濟、違約、不履行義務的棄權，只有在採用書面形式，並經棄權方簽署方生效力。
- 17.3. 如果合同任何條款被任何具有管轄權的法院或機構或當局認定為不合法、非法、無效或不可強制履行，則該條款將被視為從合同中分割，且不會影響合同剩餘部分繼續完全有效。
- 17.4. 除本條款另行明確規定外，變更合同必須經雙方書面同意並簽署。

- 17.5 No partnership, agency or joint venture between the parties will be created by the Contract.
- 17.6 Each party agrees that it is an independent contractor and is entering into the Contract as principal and not as agent for or for the benefit of any other person. Nothing in any Contract will make any individuals employed or engaged by you or any of your sub-contractors (“**Supplier Personnel**”) an employee, worker, agent or partner of us or any of our Affiliates.
- 17.7 Each of our Affiliates will be entitled to enforce in their own capacity the terms of any Contract under which that Affiliate receives a benefit and we shall also be entitled to enforce such terms on their behalf.
- 17.8 Save as provided in Condition 0, the parties do not intend that any term of a Contract will be enforceable by any person who is not a party to it.
- 17.9 You may not assign, transfer, charge, hold on trust for any person or deal in any other manner with any of your rights under the Contract or sub-contract any of your obligations under the Contract. We may assign a Contract to our Affiliates.
- 18. GOVERNING LAW AND JURISDICTION**
- 18.1 The Contract and any non-contractual obligations arising in connection with it are governed by the law of the jurisdiction in which we are registered or incorporated. The courts of such jurisdiction (and if applicable to the relevant jurisdiction any district in which we are registered) have exclusive jurisdiction to determine any dispute arising in connection with the Contract.
- 17.5. 合同不會在雙方之間設立任何合夥、代理或合資關係。
- 17.6. 各方同意其為獨立締約方，以本人而非作為代理人代表任何他人或為任何他人利益訂立合同。任何合同的條款，均不致使貴方或貴方分包商所僱用或聘用的任何個人（“**供應商人員**”）成為我方或我方任何關聯人的僱員、工人、代理人或合夥人。
- 17.7. 我方各關聯人將有權以自身能力強制履行該關聯人獲得利益的任何合同條款，而我方亦應有權代表該等關聯人強制履行該等條款。
- 17.8. 除第 17.7 條規定外，雙方並未意圖使非合同當事人的任何人強制履行該合同的任何條款。
- 17.9. 貴方不得轉讓、讓與、設定擔保、為任何人信託持有或以任何其他方式處理貴方在合同項下的任何權利，亦不得轉包貴方在合同項下的任何義務。我們可向我方關聯人轉讓合同。
- 18. 管轄法律和管轄權**
- 18.1. 合同和針對合同產生的任何非合同義務受我方註冊或成立公司所在司法管轄區的法律管轄。該司法管轄區的法院（如果適用於相關司法管轄區，我方註冊所在區）具有專屬管轄權，可裁定與合同有關的任何爭議。
